SECTION 4: FIRST AID MEASURES

SECTION 5: FIRE FIGHTING MEASURES

Suitable extinguishing media: Foam. Dry chemical. Carbon dioxide.

SECTION 6: ACCIDENTAL RELEASE MEASURES
